SUBJECT: New method of managing book coupons school year 2022/2023

The Municipality of Padua provides primary school textbooks free of charge to all students resident in the municipality. In compliance with the provisions of Article 36 of Regional Law no. 18 of 27 June 2016, from the 2018/19 school year, each family will be able to freely choose their preferred retailer from among those who have been accredited.

This Administration has implemented a new system for managing book coupons that replaces the method of transmitting the paper coupon with a system of generating coupons using computerised methods.

To use this service, the parent/guardian must go to authorised bookshops with only the child's tax code. The retailer will order and deliver the textbooks, at the expense of the Municipality.

The bookshop/bookstore, by accessing the portal with their credentials and entering the child's tax code, will see the associated coupon (if the user has already used the coupon, it will appear as already used). If the coupon is available, the shopkeeper will be able to deliver the textbooks.
